Comments

Installation instructions shall be delivered in each packaging.

Floor gullies are tested according to SS-EN 1253-1, they fulfil all requirements except:

- Minimum flow rate (0,8 l/s). Requirement for installations with one shower head is fulfilled according to the standard (0,4 l/s).
- Depth of water seal (50 mm). The partially mechanical water trap is considered to correspond to a water seal depth of 50 mm. The water trap should be cleaned regularly.

This approval supersedes the previous approval with the same number dated 2012-10-18.
