Purus pipe fittings are made of PP and are available in dimensions 32 mm and 40 mm.

Factory installed sealing rings are made of TPE.

Intended use

Fittings intended for connecting pipes in DN 32 and DN 40 for soil and wastewater discharge within the building structure. The water temperature might momentarily reach maximum 93°C.

The fittings shall be replaceable after installation.
