The aquatic toxicity for this toner carrier was determined from actual testing of an essentially similar carrier toner for acute aquatic toxicity (see GHS 4.1.3.3.2). Where the LC50 is >100 mg/l and the NOEC (no observed effect concentration) is >1.0 mg/l there is no need to classify for acute or chronic toxicity hazard. The results from the actual testing was LC50>1250 mg/l and the NOEC >2500 mg/l. This supersedes any calculation procedure for determining aquatic toxicity.
