This Limited Warranty (“Warranty”) applies to FINAL CHARGE® PRO-SERIES Extended Life Concentrate Antifreeze/Coolant and FINAL CHARGE® PRO-SERIES Prediluted, in both concentrate and prediluted (individually and collectively, “Product”) Antifreeze/Coolant (individually and collectively, “FINAL CHARGE® PRO-SERIES” or “Product” and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it.

FINAL CHARGE® PRO-SERIES features an advanced Organic Acid-based technology formula for use in On & Off Highway engines of heavy duty vehicles and stationary equipment (the “Equipment”) – without the need for supplemental coolant additives (SCA). Old World Industries, LLC (“Old World”) warrants to the owner of the Equipment (“Equipment Owner”) – for a period of **1.5 Million Miles / 2.4 Million km’s of on-road use, or 36,000 hours of off-road use or 10 years;** whichever is earlier (collectively, the “Warranty Period”) – that it will pay for the repair or replacement, at Old World’s option, of those parts of the Equipment’s antifreeze or cooling system (the “A&C System”) that fail or show abnormal wear, to be determined by Old World, as a direct result of using FINAL CHARGE® PRO-SERIES during the Warranty Period; provided that: (1) the Equipment (including its A&C System) meets and was properly used and maintained in accordance with the Original Equipment Manufacturer’s specifications and recommendations; (2) FINAL CHARGE® PRO-SERIES was installed, used and maintained (including an initial and complete A&C System flush and fill and subsequent topping off, as needed) in accordance with Old World’s specifications and with the directions on the Product labeling; (3) the Equipment was used under normal operating conditions and in accordance with Old World’s specifications; (4) the Equipment Owner maintains records verifying the condition set forth in items (1) through (3) above, including the FINAL CHARGE® PRO-SERIES sales receipt(s); as well as the repair invoice and (5) the Equipment Owner certifies that no other products have been added to the FINAL CHARGE® PRO-SERIES Product.

THIS WARRANTY IS THE ONLY EXPRESS WARRANTY THAT APPLIES TO FINAL CHARGE® PRO-SERIES AND SETS FORTH ALL OF THE OBLIGATIONS AND RESPONSIBILITIES OF OLD WORLD. IT COVERS ONLY DAMAGE TO THE EQUIPMENT’S A&C SYSTEM (PARTS AND LABOR ONLY) AS DEFINED ABOVE. ANY AND ALL APPLICABLE IMPLIED WARRANTIES ARE LIMITED TO THE TERMS, CONDITIONS AND DURATION OF THIS EXPRESS WARRANTY. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE SPECIFICALLY DISCLAIMED INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES (INCLUDING LOST PROFITS, LOST BUSINESS OPPORTUNITIES OR LOSS OF USE) ARE SPECIFICALLY EXCLUDED FROM COVERAGE UNDER THIS WARRANTY.

**State law rights: This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state or jurisdiction. Some states or jurisdictions do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states or jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.**

Allow Old World or its designated agent(s) to inspect and test the Equipment’s A&C System or part(s) claimed as damaged and take coolant and/or oil samples if necessary to determine whether FINAL CHARGE® PRO-SERIES was the cause of such claimed damage. Send the Equipment’s A&C System or part(s) claimed as damaged and coolant and/or oil samples to Old World if requested. Provide testing data of fluids such as (Coolant and Oil) from an existing fluid monitoring program.
