LIMITED WARRANTY

This Limited Warranty (“Warranty”) applies to FINAL CHARGE® Global Extended Life Coolant/Antifreeze and FINAL CHARGE® Global Extended Life 50/50 Prediluted Coolant/Antifreeze (individually and collectively, “FINAL CHARGE®” or “Product”) and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it.

FINAL CHARGE® features an advanced Organic Acid Technology formula for use in the engines of heavy-duty vehicles and stationary equipment (the “Equipment”) – without the need for supplemental coolant additives. Old World Industries, LLC (“Old World”) warrants to the owner of the Equipment (“Equipment Owner”) – for a period of **ONE MILLION MILES** or 8 years of *on-road* use, whichever is earlier (or 20,000 hours or 8 years of *off-road* use, whichever is earlier)(collectively, the “Warranty Period”) – that it will pay for the repair or replacement, at Old World’s option, of those parts of the Equipment’s antifreeze or cooling system (the “A&C System”) that fail or show abnormal wear from rust, corrosion or cavitation, as determined by Old World, as a direct result of using FINAL CHARGE® during the Warranty Period; provided that: (1) the Equipment (including its A&C System) meets and was properly used and maintained in accordance with the original Equipment manufacturer’s specifications and recommendations; (2) FINAL CHARGE® was installed, used and maintained (including an initial and complete A&C System flush and fill and subsequent topping off, as needed) in accordance with Old World’s specifications and with the directions on the Product label; (3) the Equipment was used under normal operating conditions and in accordance with Old World’s specifications; (4) the Equipment Owner maintains records verifying the condition set forth in items (1) through (3) above, including the FINAL CHARGE® sales receipt(s); and (5) the Equipment Owner certifies that no other products have been added to the FINAL CHARGE® Product.

THIS WARRANTY IS THE ONLY EXPRESS WARRANTY THAT APPLIES TO FINAL CHARGE® AND SETS FORTH ALL OF THE OBLIGATIONS AND RESPONSIBILITIES OF OLD WORLD. IT COVERS ONLY DAMAGE TO THE EQUIPMENT’S A&C SYSTEM (PARTS AND LABOR ONLY) AS DEFINED ABOVE. ANY AND ALL APPLICABLE IMPLIED WARRANTIES ARE LIMITED TO THE TERMS, CONDITIONS AND DURATION OF THIS EXPRESS WARRANTY. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE SPECIFICALLY DISCLAIMED INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES (INCLUDING LOST PROFITS, LOST BUSINESS OPPORTUNITIES OR LOSS OF USE) ARE SPECIFICALLY EXCLUDED FROM COVERAGE UNDER THIS WARRANTY.

State law rights: This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

To make a valid Warranty claim, the Equipment Owner must do both of the following:

1. Notify Old World within thirty (30) days of discovering the damage and present the documentation required in item (4) above. Please send the required claim information to:
