

**BlueDEF® Diesel Exhaust Fluid  
LIMITED WARRANTY**

This Guaranteed Pure Limited Warranty (“Warranty”) applies to all BlueDEF®-branded diesel exhaust fluid (“BlueDEF” or “Product”) supplied and sold by Old World Industries, LLC (“Old World”) to the Equipment Owner (defined below) and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it. This Warranty applies only to Product purchased from an Old World-authorized dealer or reseller, unless otherwise prohibited by law.

BlueDEF is intended for use in diesel engines of vehicles and stationary equipment (“Equipment”) that are equipped with a Selective Catalytic Reduction system (“SCR System”). BlueDEF is formulated, blended, and tested to meet ISO Standard 22241 for purity and composition and is an American Petroleum Institute (“API”)-certified diesel exhaust fluid.

OWI warrants that for a period of 90 days from Product purchase (the “Warranty Period”) that it will pay the owner of the Equipment (the “Equipment Owner”) for the repair or replacement, at Old World’s option, of those parts of the SCR System that fail or show abnormal wear, as determined by Old World, as a direct result of using off-specification and/or defective BlueDEF during the Warranty Period; provided that: (1) the SCR System was properly used and maintained under normal operating conditions and in accordance with the original Equipment manufacturer’s specifications and recommendations; (2) BlueDEF was acquired, installed, used, transported, stored and maintained in accordance with the Product specifications and directions provided by Old World on the Product label or elsewhere; (3) the Equipment Owner has maintained records and other items verifying the conditions set forth in (1) and (2) immediately above, including BlueDEF sales receipt(s), Product packaging and date codes, repair order, maintenance and service records, and retained Product samples; and (4) the Equipment Owner certifies that no other products have been added to or commingled with the BlueDEF in question.

**DISCLAIMER OF WARRANTIES/LIMITATION OF LIABILITY**

THIS WARRANTY IS THE ONLY EXPRESS WARRANTY THAT APPLIES TO BLUEDEF®-BRANDED DIESEL EXHAUST FLUID AND SETS FORTH ALL OF THE OBLIGATIONS AND RESPONSIBILITIES OF OLD WORLD. THIS WARRANTY COVERS ONLY DAMAGE TO THE EQUIPMENT’S SCR SYSTEM (PARTS AND LABOR ONLY) AS DEFINED ABOVE. EXCEPT AS EXPRESSLY SET FORTH ABOVE, EACH PRODUCT IS PROVIDED SOLELY ON AN “AS IS” BASIS AND OLD WORLD MAKES NO OTHER WARRANTIES OF ANY KIND. ANY AND ALL APPLICABLE IMPLIED WARRANTIES ARE LIMITED TO THE TERMS, CONDITIONS AND DURATION OF THIS EXPRESS WARRANTY. **ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE SPECIFICALLY DISCLAIMED INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.** CONSEQUENTIAL, INCIDENTAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES (INCLUDING LOST PROFITS, LOST BUSINESS OPPORTUNITIES OR LOSS OF USE) ARE SPECIFICALLY EXCLUDED FROM COVERAGE UNDER THIS WARRANTY.

**State law rights: This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state. 3. You must also allow Old World or its designated agent(s) to inspect and test the affected SCR System, or part(s) claimed as damaged.
4. Additionally, you must provide samples of the Product in question to assist in determining whether it was the cause of the claimed damage.
