

PEAK® Wiper Blades

Limited Warranty — Canada

This express, limited warranty (the “Warranty”) is provided by Old World Industries, LLC (“Old World”) and applies to PEAK®-branded wiper blades (each, a “Product”) purchased in Canada from an Old World–authorized dealer or reseller. This Warranty is free. No one may charge a fee for it.

What is covered.

Old World warrants that the Product will be free of defects in material and workmanship and will meet its advertised performance standards for one (1) year from the date of purchase (the “Warranty Period”). This express Warranty extends to the original consumer purchaser only and is not transferable.

What Old World will do.

If a defect covered by this Warranty arises during the Warranty Period, Old World will, at its sole discretion, either replace the defective Product or reimburse the purchase price you paid. This Warranty does not cover the cost of labor for installation, removal, or re-installation.

What is not covered.

This Warranty does not cover: (i) normal wear and tear; (ii) damage or failure resulting from improper installation, including any installation not made in accordance with the Product’s vehicle application data and applicable instructions and industry standards; (iii) damage or failure caused by misuse, neglect, abuse, accident, modification, or use in violation of accepted industry standards; (iv) use of the Product in racing, marine, aircraft, or heavy-duty, commercial, or fleet applications; or (v) cosmetic damage that does not affect Product performance.

How to make a claim.

Within the Warranty Period and within a reasonable time after discovering the defect, (1) notify Old World at the address below, and (2) at Old World’s request, send the Product and proof of purchase to the address Old World provides.

Your statutory rights.

The remedies set out in this Warranty are Old World’s sole obligations under this Warranty, and Old World’s aggregate liability under this Warranty will not exceed the purchase price you paid for the Product. Nothing in this limited Warranty excludes, restricts, or modifies any statutory warranty, condition, guarantee, or right you may have under applicable Canadian consumer protection or sale-of-goods legislation that cannot lawfully be excluded, restricted, or modified.

Additional provisions for Quebec consumers.

If this Warranty constitutes a contract to which Quebec’s *Consumer Protection Act* (the “CPA”) applies, it is provided in addition to, and does not limit or modify, the legal warranties and remedies provided to you under the CPA and the *Civil Code of Québec*, including the warranties of quality, fitness for use, and durability. Nothing in this Warranty limits your statutory rights or your right to bring proceedings in a Quebec court, including a class action authorized under Quebec law. For Quebec residents, this Warranty is governed by the laws of the Province of Quebec.

General.

This Warranty applies only to Products purchased and used in Canada. Except as provided above for Quebec residents, this Warranty is governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein. If any provision is held invalid or unenforceable, the remaining provisions will continue in effect. Old World may update this Warranty from time to time on a going-forward basis, with no effect on Products purchased before the update. No employee, dealer, representative, or reseller is authorized to modify or extend this Warranty or to make binding representations on behalf of Old World regarding the Product or this Warranty.
