

**PEAK<sup>®</sup> ANTIFREEZE + COOLANT  
LIMITED WARRANTY**

This Limited Warranty (“Warranty”) applies to all PEAK<sup>®</sup> branded Antifreeze + Coolant in both concentrate and 50/50 Prediluted (individually and collectively, “Product”) and includes all the terms and conditions stated below. This Warranty is free. No one may charge a fee for it. This Warranty is extended solely to the owner of the vehicle in question (“Vehicle Owner”) and may not be assigned, transferred, or sold. Any attempted assignment or transfer of this warranty, whether directly or indirectly, shall be null and void.

Old World Industries, LLC (“Old World”) warrants that Product will meet or exceed the performance specifications stated by Old World for each Product as found on Old World’s product labeling, websites, or in other official documentation published by Old World (“Specifications”). In the event that Product does not meet or exceed the performance specifications, Old World will replace such non-conforming Product at its cost.

For Products stating a specific Warranty Period (as set forth per specific Product below), Old World further warrants to the Vehicle Owner (“vehicle” as defined per specific Product below) – for the Warranty Period (as defined per specific Product below) – that it will, at Old World’s option, pay for the repair or replacement of those parts of the vehicle’s cooling system that, as determined by Old World, fail or show abnormal wear and tear from rust, corrosion, or cavitations as a direct result of Vehicle Owner’s use of Product during the Warranty Period; provided that: (1) the vehicle (including its cooling system) meets and was properly used and maintained in accordance with the vehicle manufacturer’s specifications and recommendations (including initial and subsequent cooling system flush and fill requirements); (2) Product was installed, used, and maintained (including an initial and complete Cooling System flush and fill and subsequent topping off, as needed) in accordance with the vehicle manufacturer’s specifications and recommendations and with the Specifications and the directions on the Product label; **(3) the vehicle (including its cooling system) was used under normal operating conditions in accordance with the vehicle manufacturer’s specifications and recommendations and with the Specifications;** (4) the Vehicle Owner maintains records verifying the condition set forth in items (1) through (3) above, including the Product sales receipt(s); and (5) the Vehicle Owner certifies continuous ownership and that no other products have been added to the Product. **In no event will any claim payment (parts and labor) be made in an amount exceeding \$1,500.00.**

Send the Equipment's A&C System or part(s) claimed as damaged and coolant and/or oil samples to Old World if requested. Provide testing data of fluids such as (Coolant and Oil) from an existing fluid monitoring program.
