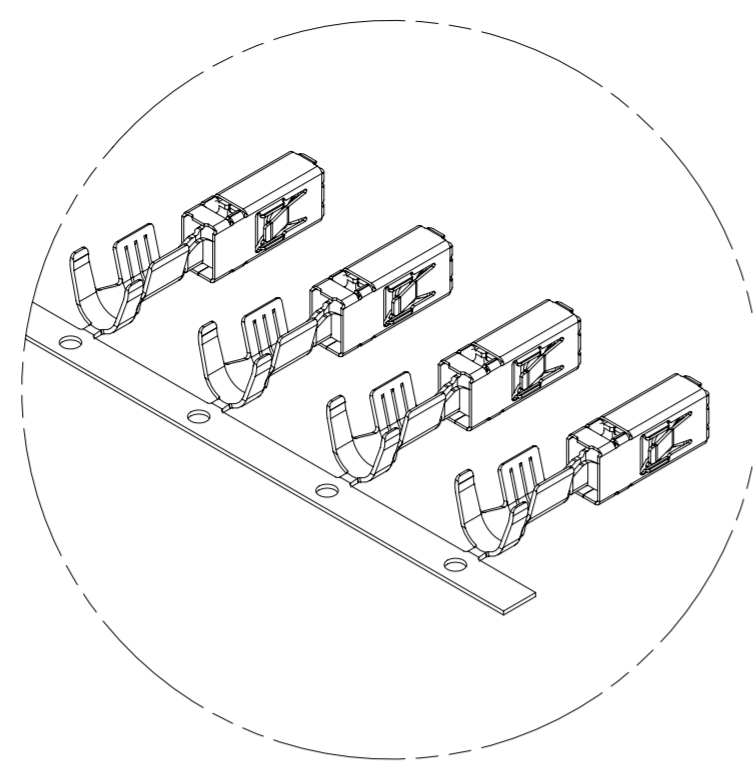

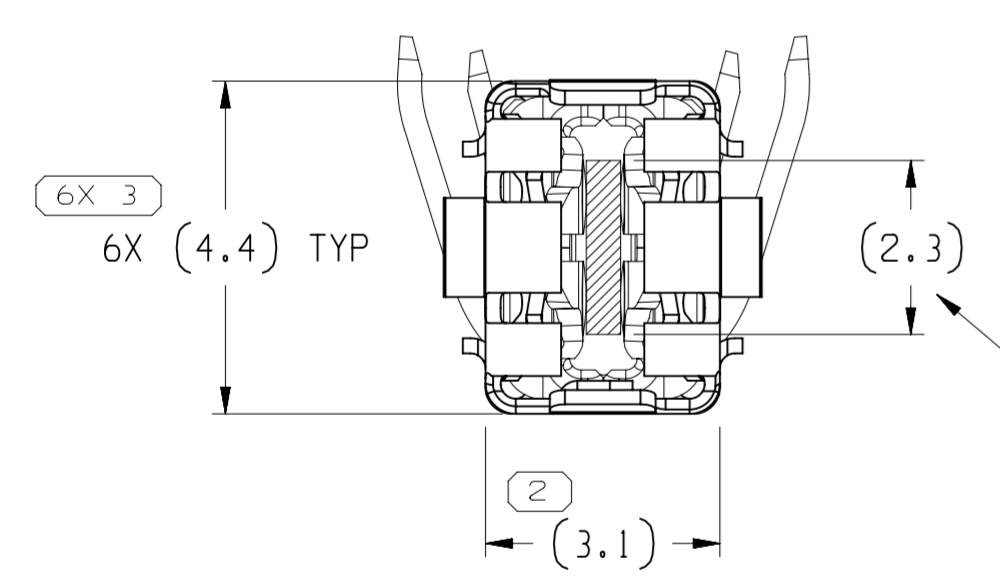
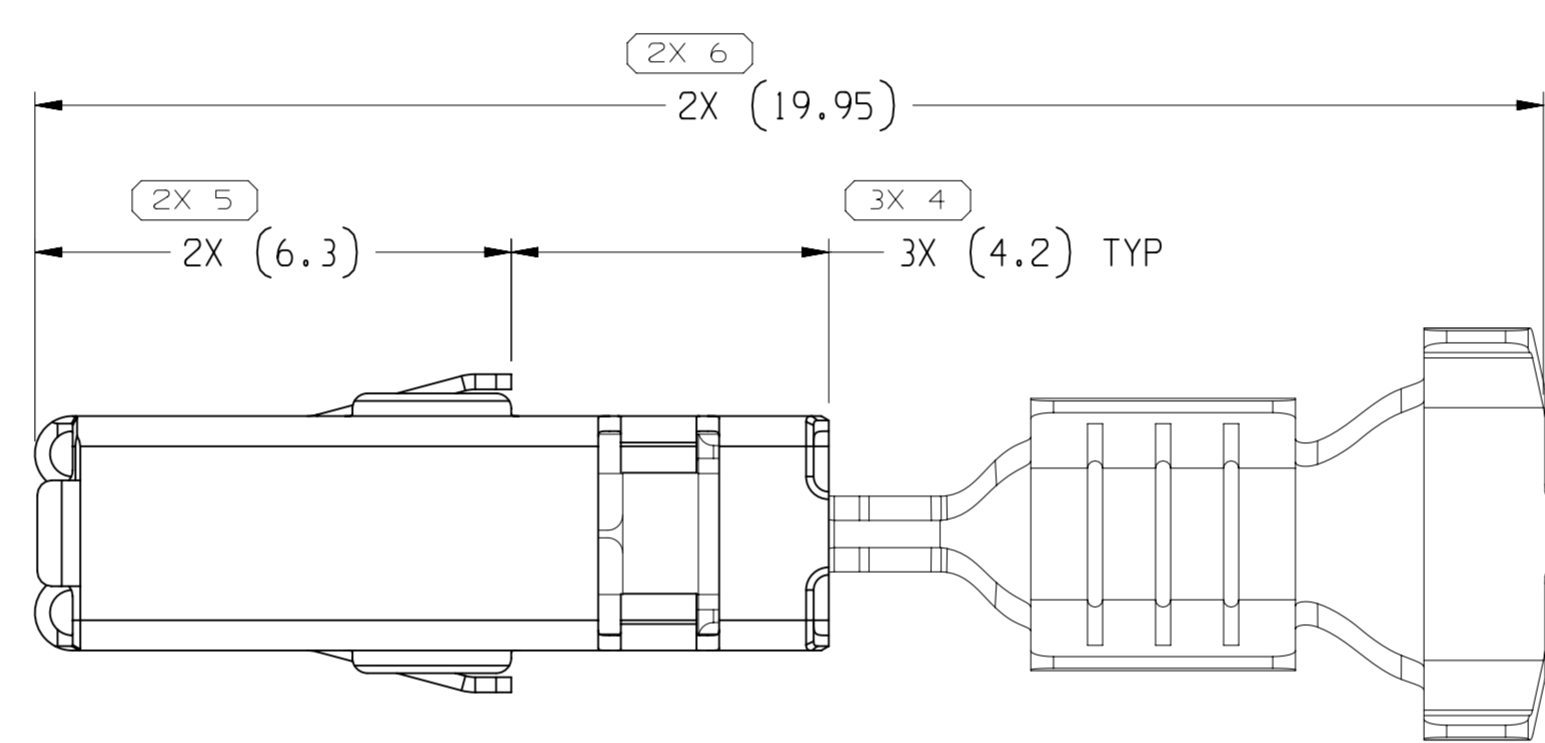
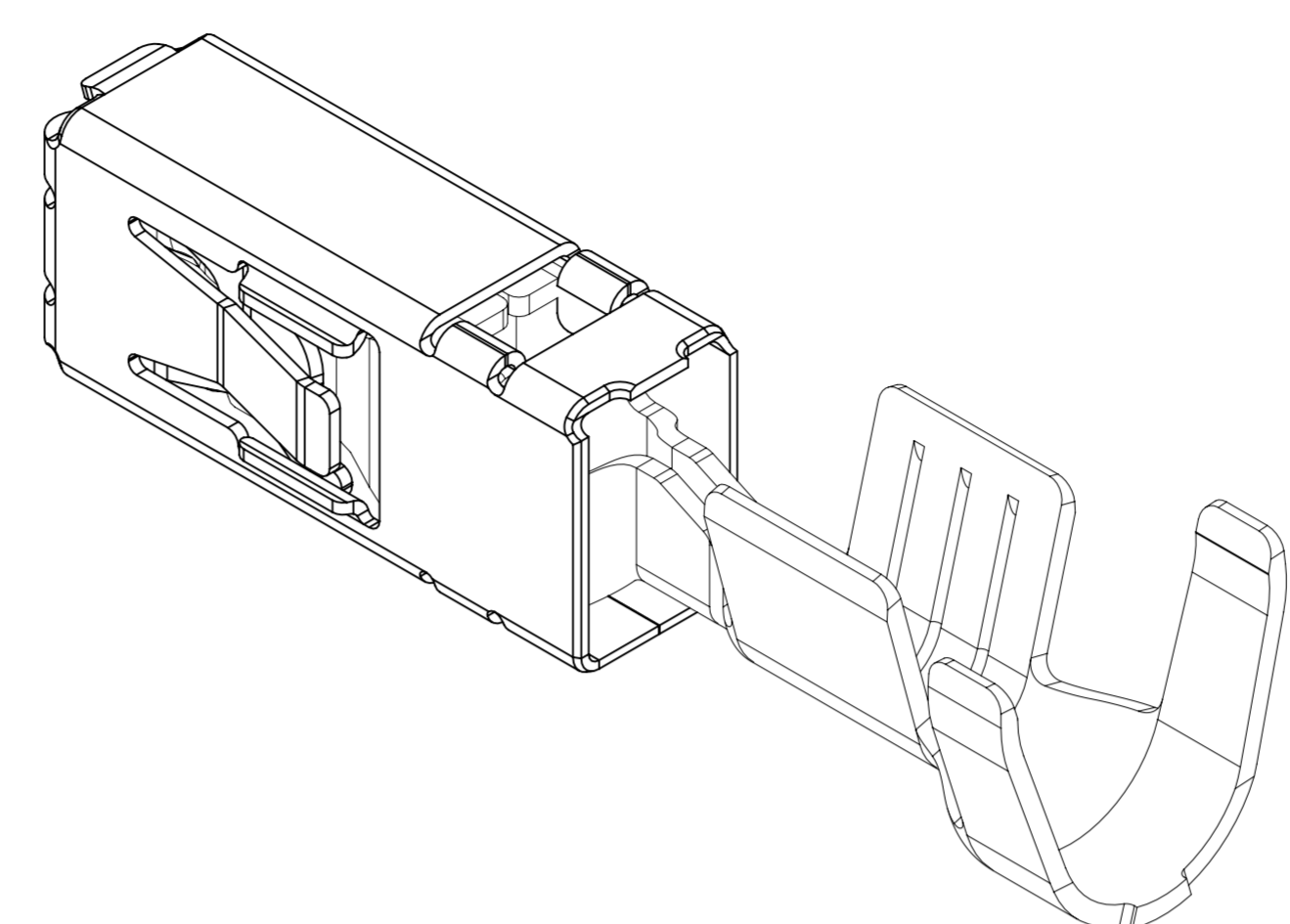
DIRECTION OF TERMINAL WINDING ON REEL AFTER GREASE



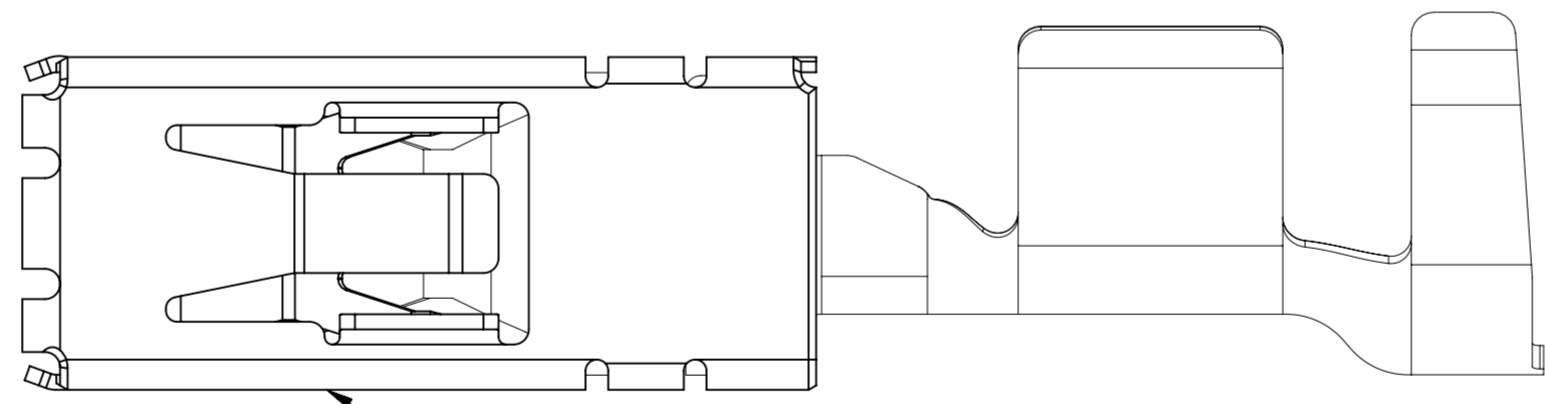
