Product Discontinuation Notice

Dear Valued Customer,

This notice is to inform you that ADB SAFEGATE is discontinuing the sourcing and supplying of all fittings and the spare parts from the steady-burning ERNI portfolio: IL 241/IL 243, IL 254D, IL 254R/IL 258, IL 83xD, IL 850D REH, IL 860D THR RWE, IL 868D, IL 87xD RCL, IL 880D, IL 88xD, IL860D, EL 824D, EL 828D. The scope of this notice does not include any previously discontinued ERNI fittings, the Sequential Flashing Light/Threshold Indication Light fittings, installation, and mounting products.

In accordance with ADB SAFEGATE product discontinuation policy, we are hereby giving notice of these changes so that our customers can adjust their product part number purchasing records or make any final lifetime purchases of spare parts to support their operations.

ERN lights have been a part of ADB Safegate portfolio since 2016. ADB Safegate has been focussing on harmonizing the AGL portfolio, which has evolved since then and currently AXON-inset and Reliance elevated fittings can be offered using the industry's cutting-edge technology enabling highly efficient light output and long operational lifetime.

ERNI fittings have been installed in mainly Central and Eastern Europe. ADB Safegate stands behind every commitment in this region and is offering the customers a last time buy opportunity until 22 December 2023 for exclusively products and spares currently in stock. Beyond this date no orders for any of the discontinued products will be accepted and the inventory of remaining parts will be discarded.
